- 2. Conduct a Public Hearing and Consider a Specific Use Permit to allow a new Assisted Living Facility within ½ mile of an existing group or community home. The property is located within the Harvest Hill subdivision, Block B, Lot 1, Lancaster, Texas and addressed as 218 Mimosa.
- Conduct a Public Hearing and Consider an amendment to the City of Lancaster Comprehensive Plan, Master Thoroughfare Plan, to remove a previously recommended alignment and/or connection of the east-west roadway extension of Springfield Avenue to Houston School Road and the extension of Oak Farms Boulevard to the Interstate 20 service road.

4. Conduct a Public Hearing and Consider an amendment to the City of Lancaster Comprehensive Plan, Master Thoroughfare Plan, to expand the recommended right-ofway to One hundred and thirty feet (130') along Pleasant Run Road from Lancaster-Hutchins Road to the easternmost City limits.
